### **Business:**

Mike started with information concerning the SA branch joining the national branch of AEVA,  
Concerns included control of monies and activities.  
The Executive watched a video stream of the WA meeting held Wednesday 20/08/08,

Notes from that meeting,  
WA has 78 financial members who contribute \$40 a year to the national body, the WA branch received \$1000 in return to run the branch of which they have \$481 left, WA noted that they will get less this year.  
Membership monies goes to the national body AEVA who are incorporated in NSW only. It is noted in the constitution that AEVA can exercise its powers in what ever way it chooses.

Discussion on the constitution – if the SA branch was to join with the National branch then we as a body would like some changes or removal of some wording of the constitution.

### **Presentation: 20.28pm**

Presentation was given by Peter Pudney – Mathematician UNISA, Peter spoke on solar car technology and electric car technology , Introducing UNISA electric car – TREV, 3 wheel, 2 seater electric car. Power point presentation of the build process of TREV, incorporating some details of body materials etc,

Peter also has taken on a project called “planning for electric vehicles in Australia” which entails research into what effect electric vehicles will have on Australia, working with fleet companies etc.
